MPC'S SERVICES ARE NOT APPROPRIATE FOR EMERGENCY MEDICAL CONCERNS.

- 1. **Description of Services**. The Site provides patients, 18 years and older, treatment options through MPC, if desired (the "Services"). The Services may include such features as:
 - a. Reviewing information on the Site about depression and anxiety, treatments for these and other behavioral health conditions, and how to access these treatments.
 - b. Connecting with a licensed Healthcare Provider who is affiliated with or employed by MPC ("Healthcare Providers") for treatment.
 - c. Receiving mental health services, including psychiatric care on a recurring basis.
 - d. Monitoring your care and progress through other tools and resources.
- 2. Nature of Services. The specific features of the Services offered by MPC may change from time to time, and MPC, at its sole discretion, may choose to discontinue some or all of the Services. If Service changes are made, MPC will make all reasonable efforts to ensure you receive notice of these changes in a timely fashion.
- 3. **Healthcare Treatment**. Services offered by Healthcare Providers, including mental health diagnoses, medical advice, and therapy and psychiatry (including the prescription of medication) for treating depression, anxiety, and/or other behavioral health issues is available in Texas only.

To receive such Services, you must agree to

- all MPC policies and procedures, which shall consist of: (1) your voluntary authorization to the rendering of treatment by Healthcare Providers as deemed necessary in their professional judgment;
- (2) your acknowledgement that no guarantees have been made as to the effect of such treatment;
- (3) your understanding that you have the right to refuse any treatment and discuss any treatments

with healthcare providers; and (4) your understanding that you are responsible for the payment of these Services as provided to you.

You understand that MPC provides a platform and mechanism for you to connect with Healthcare Providers, and that the Services you receive from your Healthcare Provider will ultimately be made at the professional discretion of the provider.

- 4. **Agreement to Terms**. By using our Services, you agree to be bound by these Terms. If you don't agree to be bound by these Terms, do not use the Services.
- 5. **Privacy**. Please refer to our privacy policies located on our website, which details your healthcare privacy rights.
- 6. Changes to Terms. We may update the Terms at any time, at our sole discretion. If we do so, we'll let you know either by posting the updated Terms on the Site, or by reaching out to you directly. It's important that you review the Terms whenever you use the Services, and periodically thereafter to see if they have been updated. If you continue to use the Services after we have posted updated Terms, you're agreeing to be bound by the updated Terms. If you don't agree to be bound by the updated Terms, then you may not use the Services anymore. Because our Services are evolving over time, we may change, add to or discontinue all or any part of the Services, at any time and without notice, at our sole discretion.

7. Who May Use the Services?

- a. **Eligibility**. You may use the Services only if you are 18 years or older and capable of forming a binding contract with MPC and are not barred from using the Services for any other reason.
- b. **Registration and Your Information**. If you want to use the Services offered by MPC, you'll have to create an account ("Account") via the Site.
- c. Accuracy of Account Information. It's important that you provide us with accurate, complete and up-to-date information while creating your Account, and that you agree to update such information to ensure it remains current. If you don't, we might have to suspend or terminate your Account.

- d. Account Protection. You agree that you won't disclose your Account password to anyone, and that you'll notify us immediately of any unauthorized use of your Account. You're responsible for all activities that occur under your Account, whether or not you're aware of these activities.
- 8. **Payment**. MPC requires payment of a fee for its Services. IF YOU DECIDE TO USE HEALTH INSURANCE TO PAY FOR YOUR SERVICES AND HAVE QUESTIONS ABOUT YOUR FINANCIAL OBLIGATIONS, YOU SHOULD CONTACT YOUR INSURANCE PROVIDER DIRECTLY.
 - a. General. When you use MPC's Services (the "<u>Transaction</u>"), you expressly authorize us (or our third-party payment processor) to charge you for the Transaction. We may ask you to supply additional information relevant to the Services and Transaction, including your credit card number, the expiration date of your credit card and your email and postal addresses for billing and notification ("<u>Payment Information</u>"). We may ask you to provide insurance information, including your insurer, ID number, RxBin number, and RxPCN number. By providing us with your Payment Information, you represent and warrant that you have the legal right to use all payment methods represented by any such Payment Information. When you initiate a Transaction, you authorize us to provide your Payment Information to third-parties with whom we partner so we can complete your Transaction and charge your Payment Information for the type of Transaction you have selected (plus any applicable taxes and other charges).  - b. Other Fees. You agree to pay all other fees and charges including, for example, appointment no-show fees or late rescheduling fees ("Other Fees") associated with your Services and Transaction on a timely basis. By providing us with your Payment Information, you authorize us to bill and charge your Services and Transaction using your Payment Information, and agree to maintain valid Payment Information with MPC.
 - c. **Insurance**. In certain situations, you or a family member's health plan may cover all or a portion of your use of Services. Subject to the terms of any written agreement between MPC and the health plan, you authorize us to bill for Services rendered to you by sharing

necessary information with the health plan to process payments. Additionally, you authorize MPC to charge your Payment Information for any fees that your insurance company does not cover, such as copays, deductibles, and coinsurance costs.

- 9. **Use of Services**. We invite you to use the Services for personal and non-commercial purposes. When you accept these Terms, we grant you a limited, personal, non-exclusive, non-transferable, fully revocable license to access and use the Services as permitted under these Terms and any other agreements you may have entered into with us. You have no other rights in or to the Services or any materials or content available therein (the "Content"), and you may not modify, edit, copy, reproduce, create derivative works of, reverse engineer, alter, enhance or in any way exploit any of the Services or Content in any manner. If you breach any of these Terms, your Services and/or Subscription may be terminated at our sole discretion.

 entity.
- 11. **Intellectual Property**. You hereby expressly acknowledge that MPC or its licensors own all legal right, title and interest to the Site and Services. MPC reserves all rights not expressly granted in and to the Service. Except as otherwise required or limited by applicable law, any reproduction, distribution, modification, retransmission, publication or other commercial use of any copyrighted material is strictly prohibited without our express written consent or the express written consent of the copyright owner or licensor.

We make no warranty regarding the quality, accuracy, timeliness, truthfulness, completeness or reliability of any Content.
- 14. Clinical Disclaimer. MPC DOES NOT RECOMMEND OR ENDORSE ANY SPECIFIC DRUGS, TESTS, PRODUCTS, PROCEDURES, OPINIONS, "OFF-LABEL" DRUG USES, OR OTHER INFORMATION THAT MAY BE MENTIONED THROUGH SERVICES, and does not represent that Services provided on the Site are always an appropriate substitute for in-person medical services. Furthermore, Services are never appropriate for emergency situations.
- 15. **Indemnity**.
